# Industry restructures – cause or solution to industry failure?

The Australian Wool Growers Association (AWGA) rejects the call for more Government interference and Industry restructure.

AWGA Chairman Martin Oppenheimer says that New South Wales Senator Fierravanti- Wells's recent call for yet another Government review into the Australian wool Industry is not supported by woolgrowers and may cause industry failure.

The timing of the Senator's negative attack on the Australian Wool Industry is not helpful as voting for WoolPoll 2009 closes at 5pm on Friday 6 November.

"If these were real issues supported by growers surely they would have been nominated by the independent WoolPoll Committee for inclusion in WoolPoll voting papers which go out to all 50,000 wool levy payers"

"Fortunately woolgrowers are now in charge of their Industry and the overwhelming grower vote at the Australian Wool Innovation Director's election in 2008 stands. Growers wanted positive change and that is what they are getting."

"Growers have had a gutful of interference by people who are not reliant on wool for their income. We need people with a vested interest in wool. The skills set and experience on the AWI Board are outstanding."

Since 1936 the Australian Wool Industry has had 23 Government legislated and woolgrower funded research, marketing and testing organisations averaging 3.2 years per organisation.

During the last eighteen years, since 1991, we have had 13 wool organisations averaging 1.4 yrs per organisation.

"Anyone who thinks that yet another wool organisation will solve all our problems is misguided."

"We need to work as a united industry with what we have and have sustainable improvement. It's time to support our industry, not destroy it."

AWGA supports the current AWI Board structure, democratic election system and growers' right to determine the level of wool levy they pay. AWGA is recommending growers vote 2% at WoolPoll 2009.
